Membership

Membership is open only to defense lawyers, law professors, and those professionals and law students directly involved in the defense function.

Life Member (\$5,000)

Life Members contribute a one-time membership dues payment of \$5,000. They also receive an elegantly framed certificate, special recognition at an OCDLA seminar, in the Membership Directory and in *The Oregon Defense Attorney*. Plus, they have the knowledge that they have contributed to the financial stability of the Association.

Sustaining Member (\$550)

Regular Member (\$255/\$360)

Regular Members dues are \$255 if your bar entry year is within the last five years, or \$360 otherwise.
